



Message from the Executive Vice President and Chief Operating Officer

On the eve of its 120th anniversary, Kruger prides itself on turning renewable resources into everyday essentials that consumers and businesses rely on for their exceptional quality and sustainability. Day in and day out, we accomplish this mission with the utmost concern for protecting our environment and improving the quality of life of our communities. This commitment is more vital than ever in a context where disruptions caused by climate change are increasing while the global economy and the workplace are experiencing profound transformations.

In its various activity sectors, Kruger is a pioneer in sustainable development. In Montréal, we have been making paperboard from 100% recycled fibres since 1961. Across North America, our Energy division operates 46 renewable energy sites with a combined installed capacity of 650 MW. All of our manufacturing facilities have a certified tracking system which enables us to guarantee that the virgin fibres we use come from well-managed forests.

This Report presents the many accomplishments of our sustainability teams while also inspiring us to keep improving.

In recent years, we have significantly lowered our GHG emissions and water consumption. Our Energy division has increased its production of renewable energy and commissioned its first allelectric trucks. The vehicles started transporting tissue products between two Kruger Products facilities in Québec. In addition, thanks to our Green Value Creation Program, several Kruger plants have improved their energy efficiency after modernizing their manufacturing equipment (pp. 7-8).

In everything we do, our business strategy is centred on the circular economy. In addition to being one of the largest recyclers of paper and paperboard in North America, Kruger recovers and reuses as much as possible the materials resulting from its activities (pp. 10-11).

Our commitment to our communities is reflected in our constant attention to the health and safety of our employees, business partners and other stakeholders, as well as in our involvement in a multitude of social causes (pp. 12-15).

We believe that honest and ethical conduct is key to a sustainable business. Kruger takes all the necessary measures to ensure that we respect human rights, that we comply with all laws and regulations in effect where we do business, and that we protect privacy. Our various corporate policies allow us to continue to grow while fostering the well-being of our teams and reducing our environmental footprint (pp. 16-17).

Achieving our sustainability goals depends above all on our 5,000 employees who, every day, make every effort to lower the impact of our activities and to maintain healthy and safe workplaces. I thank them for their valuable contribution!

Environmental Protection and Climate Change

Aware of the gravity of the climate crisis, we are committed to constantly increasing our efforts to minimize our environmental footprint.

REDUCING OUR GHGs THROUGH INNOVATION

Since 2017, we have invested \$89 million in 57 projects aimed at reducing our impact and fighting climate change.

Ultimately, the initiatives under way will enable us to reduce our GHG emissions by more than 155,000 tonnes per year.

Each year, Kruger strives to improve our energy efficiency, use a greater proportion of recycled materials in the manufacture of our products, and to lower our water consumption. We also recover the vast majority of biosolids generated from paper production.

Our desire to rely on innovation to reduce our environmental footprint is embodied in our Green Value Creation Program. The goal of this program is to modernize our manufacturing equipment as a way to constantly decrease our energy consumption.

KEY PROJECTS IN 2022



Kruger Products Sherbrooke Plant

To generate steam for this tissue plant, we have replaced the use of natural gas with biomass cogeneration. In total, we have converted 17,000 tonnes of construction waste that would otherwise have ended up in landfills. Thanks to this greener power supply, the tissue plant is able to generate steam without having to use natural gas most of the time and has reduced its GHG emissions by 20%.



Kruger Products Crabtree Plant

One of the paper machines at this Kruger Products tissue plant was completely modernized, which enabled us to decrease the Plant's natural gas consumption by more than 3 million m³ per year. Machine upgrades included reducing heat from the convection drying hood gases, as well as improving the steam dryer insulation. GHG emissions have been reduced by more than 6,000 tonnes per year, which represents a 30% reduction for this paper machine, and a 10% reduction for the entire facility.



Kruger Wayagamack (Trois-Rivières)

The black liquor recovery boiler at this paper mill has been modernized. The boiler's air intake is now automated, which has reduced our GHG emissions by 5,600 tonnes per year. The recovery boiler enables the Mill to burn the black liquor, a by-product of paper manufacturing, to generate energy and recover its chemical compounds.

OTHER ENVIRONMENTAL PROTECTION MEASURES:

Sustainability assessment for our largest suppliers through the EcoVadis platform.

Implementation of an environmental qualification process for contractors before they enter our facilities.



Our vision of a low-carbon future is materialized in particular through our Energy division, which is dedicated exclusively to the development and operation of renewable energy power plants, including hydroelectricity, wind, solar, and biomass cogeneration facilities, as well as energy storage.



TOTAL: 652 MW

In 2022, two new projects were added to Kruger Energy's portfolio. Our team commissioned the 24-MW Des Cultures Wind Farm located in the towns of Saint-Rémi and Saint-Michel, in the Montérégie region of Québec. This project was created through a partnership with Kahnawà:ke Sustainable Energies. We also commissioned a 9-MW solar facility in Zacapa. Guatemala.

Overall, those projects represented investments in renewable energy totalling close to \$85 million.

Water Consumption

In recent years, our teams' concerted efforts, combined with the use of leading-edge technology, enabled us to reduce substantially the amount of water required for our operations.

Acquisition and Commissioning of Electric Trucks

In November 2022, Kruger Energy commissioned its first 100% electric trucks. These Class 8 heavy vehicles are among the first to hit the road in Canada.

The two trucks transport materials and tissue products such as Cashmere®, SpongeTowels® and Bonterra™ between Kruger Products facilities located in Québec. The vehicles are on the road 20 hours per day, seven days a week, and will eventually reach an average of 1,000 km per day.

The use of these vehicles will reduce our GHG emissions by 380 tonnes per year, which is equivalent to removing 90 passenger cars from the roads. Fossil fuel savings will reach 150,000 litres per year.

In addition to their positive impact on air quality, the electric trucks are much quieter than traditional heavy vehicles and will contribute to reducing noise pollution on our roads.

The commissioning of these trucks is only the beginning since our aim is to electrify our fleet as much as possible over the coming years. Our Energy division has already ordered 50 more electric trucks to be able to deploy 15 to 20 more on the roads by 2025.

Moreover, Kruger Energy has acquired its own charging stations, which enables us to collect a vast quantity of data on truck battery usage and recharging.

SUSTAINABLY FOCUSED HOUSEHOLD PAPER PRODUCTS

In 2022, our Kruger Products division introduced Bonterra™, a sustainably focused portfolio of household paper products.

Manufactured at our mills in Crabtree and Gatineau, Québec, Bonterra™ bathroom tissue, facial tissue and paper towels are made from FSC®-certified recycled fibres and wrapped in plastic-free paper packaging.

To further illustrate our commitment to sustainability, Bonterra™ partnered with 4ocean® to fund the annual removal of 10,000 lbs. of plastic waste from our oceans, rivers, and coastlines. Our environmentally focused brand also funds the planting of 30,000 trees annually through a partnership with One Tree Planted®.

The introduction of the Bonterra[™] portfolio, which is produced in a carbon-neutral manner, is in line with Kruger Products' sustainable development initiative, Reimagine 2030, which

sets ambitious environmental targets. Among other things, our division aims to reduce virgin plastic packaging in trademark products by 50% by 2030.



Responsible Sourcing and Circular Economy

OUR COMMITMENT

We take the necessary steps to ensure that the resources used in our facilities come from suppliers who maintain best environmental practices. We also make sure that, in carrying out their activities, they respect the communities in which they operate.

The principle of circular economy is an integral part of our business strategy as it allows an efficient use of resources, as well as the elimination of waste throughout the life cycle of our products.

OUR PERFORMANCE

More than 1 million tonnes of recycled material used to manufacture our products or generate energy, including:

- · More than 750,000 tonnes of fibres recycled in our facilities across Canada, making Kruger the largest recycler in the country.
- · 118,000 tonnes of construction waste.
- · 161,000 tonnes of paper mill sludge and sawmill waste.

More than 90% of sludge generated by our paper mills has been recovered and diverted from landfills. All of the fly ash from biomass cogeneration has been recovered and used in the production of concrete.

KRUGER RECYCLING

Active in this field since 1979, Kruger is the largest recycler in Canada. Our Recycling division offers a complete range of services for the collection and responsible management of paper, cardboard and wood waste for industrial and commercial businesses and institutions, mainly in the Montréal and Estrie regions of Québec.

The collected material is integrated into the production cycles of our mills for the manufacture of various products such as Kruger Products' tissue brands, including Cashmere® and Purex® bathroom tissue, Scotties® facial tissue, SpongeTowels® paper towels, and the Bonterra™ products line.

Recovered cardboard is also used in the manufacture of many of our products, including boxes, food packaging and building materials.

Construction and sawmill residues are used in particular to fuel our biomass cogeneration facilities. The renewable energy they generate is used in some of our plants and allows us to reduce our consumption of fossil fuels.

RESPONSIBLE FIBRE SOURCING

To ensure that the forest resources used in our operations are produced responsibly, all of our facilities have monitoring systems certified to FSC° , SFI° or $PEFC^{TM}$ standards. These make it possible to confirm that the virgin fibres come from certified and well-managed forests. The same applies to controlled or recovered resources.









ECOLOGO® CERTIFICATION

We market 59 ECOLOGO®-certified products which have been assessed for reduced environmental impact. These are mainly within our lines of bathroom tissue, facial tissue, paper towels and napkins.


